#### Decision 1/2012 Intersessional Work Program

- 3. With respect to the remaining 32 PIFs approved as part of the work program, the Council finds that each of these PIFs (i) is, or would be, consistent with the Instrument and GEF Policies and procedures, and (ii) may be endorsed by the CEO for final approval by the GEF Agency, provided that the final project documents fully incorporate and address the Council's and the STAP reviewer's comments on the work program, and that the CEO confirms that the project continues to be consistent with the Instrument and GEF policies and procedures.

4. With respect to any PIF approved in this work program, the final project document will be posted on the GEF website for information after CEO endorsement. If the GEF CEO determines that there have been major changes to the project scope and approach since PIF approval, the final project document shall be posted on the web for Council review for four weeks prior to CEO endorsement.

## 42<sup>nd</sup> Council Meeting – June 2012

#### Decision 2/2012 Relations with the Conventions and Other International Institutions

1. The Council, having considered document GEF/C.42/03, Relations with the Conventions and Other International Institutions, welcomed the report and requested the GEF network to continue working with recipient countries to reflect the guidance and national priorities in their respective GEF programming and activities.

#### Decision 3/2012 Annual Performance Report 2011 and Management Response

The Council, having reviewed document GEF/ME/C.42/01, <u>Annual Performance Report 2011</u>, and document GEF/ME/C.42/02, <u>Management Response to the Annual Performance Report 2011</u>, noted that evidence emerges that the GEF Agencies are starting to involve GEF Operational Focal Points in a more systematic manner in monitoring and evaluation. The Council requested the GEF Agencies to continue to enhance their efforts to specify how Operational Focal Points will be engaged, when feasible and relevant, in project or program monitoring and evaluation.

## Decision 4/2012 Annual Country Portfolio Evaluation Report 2012 and Management Response

- The Council, having reviewed document GEF/ME/C.42/03, <u>Annual Country Portfolio Evaluation Report 2012</u>, document GEF/ME/C.42/04, <u>Management Response to the Annual Country Portfolio Evaluation Report 2012</u>, and having taken note of the two Country Portfolio Evaluations in Nicaragua and OECS (GEF/ME/C.42/Inf.02) requested the Secretariat:
  - 1) To consider ways to make project approval and implementation in Small Island Developing States more flexible and context-specific.
  - 2) To reduce the burden of monitoring requirements of multifocal area projects to a level comparable to that of single focal area projects.

3) To enable South-South cooperation activities as components of national, regional and/or global projects where opportunities for exchange of technology, capacity development and/or sharing of best practices exist.

## Decision 5/2012 Terms of Reference and Budget for the Fifth Overall Performance Study of the GEF

1. The Council, having reviewed document GEF/ME/C.42/05, <u>Terms of Reference and Budget for the Fifth Overall Performance Study of the GEF</u>, approved these terms of reference, as well as the budget for an amount of USD 1.075 million, to be incorporated in the multi-annual budget of the Evaluation Office. The Council requested the Evaluation Office to implement OPS5 and to provide the first and final reports to the Replenishment process and to the Council according to the schedule presented.

#### Decision 6/2012 Work Program and Budget of the GEF Evaluation Office

- 1. The Council, having reviewed document GEF/ME/C.42/06, <u>Work Program and Budget of the GEF Evaluation Office</u>, approved the annual budget for the Evaluation Office for fiscal year 2013 for a total of US\$2.74 million.
- 2. The multi-annual budget for the evaluation program of the GEF Evaluation Office is approved for an amount of US\$ 3 million for evaluations carried out in fiscal year 2013 and evaluations continuing on into fiscal year 2014. This amount includes the funding approved by the Council for the Fifth Overall Performance Study and the mid-term evaluations for STAR and the NPFE/CSP related activities of the GEF, as requested by Council.

#### Decision 7/2012 Broadening the GEF Partnership: Clarification of Responsibilities

1. The Council took note of the paper GEF/C.42/04, <u>Clarifying the Responsibilities of the GEF's Key Actors with respect to the Use of GEF Resources</u>, approved the approach presented in the paper to strengthen Financial Procedures Agreements (FPAs) and requested the Trustee and the Implementing and Executing Agencies to prepare amendments to the existing FPAs to include appropriate provisions and requested the Trustee to include similar provisions in any new FPAs with GEF Partner Agencies.

#### Decision 8/2012 Annual Monitoring Report 2011: Part II

1. The Council, having considered document GEF/C.42/05/Rev.01, <u>Annual Monitoring</u> <u>Report (AMR) 2011: Part II</u>, welcomed the report and appreciated the reformed AMR process. The Council requested the GEF to continue providing two AMR reports. The first, presented in the fall, containing a quantitative overview of information on the

- portfolio under implementation; and the second, presented in the spring, containing more in-depth analysis of outcomes, experiences, and lessons learned.
- 2. The Council also supported the Secretariat's recommendation to include the following information in Part I and Part II of the AMR, beginning with the next AMR:
  - a) An annual status update on Enabling Activities, Programmatic Approaches and the Small Grants Programme
  - b) Information on the influence of the National Portfolio Formulation Exercise (NPFE) process and products on GEF-5 programming
  - c) Reflection of the cumulative results against replenishment targets.

#### Decision 9/2012 Work Program

- The Council, having reviewed document GEF/C.42/06, <u>Work Program</u>, approved the
  work program¹ comprising eighty four (84) project concepts and two programmatic
  approaches, subject to comments made during the Council meeting and additional
  comments that may be submitted in writing to the Secretariat by June 21, 2012.
  Thirteen (13) other project concepts associated with previously approved programmatic

- 4. Furthermore, the Council approved them with the understanding that they will seek, as appropriate, to collaborate with the future Climate Technology Centre to be set up in the framework of the UNFCCC.
- 5. With respect to the PIFs approved as part of the work program, the Council finds that each of these PIFs (i) is, or would be, consistent with the Instrument and GEF Policies and procedures, and (ii) may be endorsed by the CEO for final approval by the GEF Agency, provided that the final project documents fully incorporate and address the Council's and the STAP reviewer's comments on the work program, and that the CEO confirms that the project continues to be consistent with the Instrument and GEF policies and procedures.

- 6. With respect to any PIF approved in this work program, the final project document will be posted on the GEF website for information after CEO endorsement. If the GEF CEO determines that there have been major changes to the project scope and approach since PIF approval, the final project document shall be posted on the web for Council review for four weeks prior to CEO endorsement.
- 7. The detailed funding decisions taken by the Council during this 42<sup>nd</sup> Council meeting are included in Table 1 annexed to this Joint Summary of the Chairs.

#### Decision 10/2012 Business Plan FY 13-14 and Budget, FY13

- 1. The Council, having reviewed document GEF/C.42/07/Rev.01, <u>Business Plan FY13-14 and Budget, FY13</u>, took note of the business plan and approved an FY13 corporate budget from the GEF Trust Fund of \$30.628 million comprising:
  - (a) \$18,525,000 for the GEF Secretariat;
  - (b) \$2,311,000 for the STAP;
  - (c) \$3,202,000 for the Trustee's core budget and the cost of external audits; and
  - (d) \$5,740,000 for the Evaluation Office, comprising \$2,740,000 for its core annual budget and \$3,000,000 in funding for multi-year evaluations.
  - (e) \$850,000 for a Trustee special initiative, referred to in paragraph 40 (d), that will implement the recommendations arising from the independent assessment of GEF systems completed in FY11 at the request of the Council. An additional \$150,000 will be paid as follows: \$100,000 from the Least Developed Countries Fund (LDCF) and \$50,000 from the Special Climate Change Fund (SCCF).
- 2. The Council also approved the following allocations from the Nagoya Protocol Implementation Fund (NPIF) to cover the Secretariat's and Trustee's expenses for administering the NPIF during FY13:
  - (a) \$\$345,000 for the GEF Secretariat;
  - (b) \$ 72,300 for the Trustee;
- 3. Given that administrative expense for NPIF were not approved by the Council in the FY12 budget, the Council also approved the following allocations, from the NPIF, to reimburse the GEF Secretariat's GEF Trust Fund administrative budget and the Trustee for expenses incurred in administering the NPIF from its inception through June 30, 2012:

- (a) \$218,000 for the GEF Secretariat;
- (b) \$76,000 for the Trustee;
- 4. Council requested the Secretariat, in consultation with the GEF entities, to present a combined FY14 corporate budget and FY14 business plan for discussion at its spring 2013 meeting. This combined budget and business plans should report on the use of GEF resources during FY13 and GEF accomplishments over the same period. It should also present a refined plan for programming and policy implementation during the final year of GEF-5.

#### Decision 11/2012 Fee Structure for Agencies: Part I

- 1. The Council, having considered document GEF/C.42/08, <u>Fee Structure for Agencies</u>, <u>Part </u> *I*, expressed its appreciation to the Fee Working Group on further developing this structure.
- 2. While reaffirming strongly the importance of the partnership, the Council accepted the fee structure as proposed by the Fee Working Group outlined in this document, and welcomed the commitments of the Agencies to implement the approved fee structure.
- 3. The Council confirmed that annexes A, B, and C are not associated with this decision.
- 4. Furthermore, the Council requested a working group, comprised of Council Members, Agencies, and the Secretariat, to propose at the November 2012 meeting, detailed streamlining measures in the project cycle and cost savings in implementing services provided by Agencies at least commensurate with the approved fee structure.
- 5. The Council requested the Secretariat to begin implementation of the new structure beginning January 01, 2013.

<u>Impact Report 2012</u>, took note of the considerable achievements of GEF support to the South China Sea and adjacent areas including, amongst others, that in 21 of 26 cases where comparative data could be obtained, GEF has supported initiatives that reduced environmental stress and improved or maintained socioeconomic conditions.

- 2. Given the important contributions that GEF support has made to addressing regional transboundary concerns, and the role of the GEF as a critical player in the region, as noted by the report, the Council requested the Secretariat to:
  - 1) Take into account the findings and recommendations of this evaluation when screening future proposals submitted for GEF funding in the South China Sea and adjacent areas, most notably:
    - when choosing areas for expansion, that the conditions conducive to broader adoption are present in those areas
    - that the distinctive competencies within the GEF partnership are more fully drawn on to mainstream transboundary environmental concerns among sectorial ministries
    - that systems for managing risks and trade-offs are specified
    - that more attention is given to the support of actions that address regional environmental goods and services
    - that cash and in-kind cofinancing for regional services provided by GEF projects reach sustainable levels by project end • that adequate coordination and management of risks within the GEF partnership be given attention.
  - Adopt a more robust tracking and reporting approach to ensure Agency accountability for collaboration and cooperation in the South China Sea and the East Asian Seas.
  - 3) Take in to account the findings and recommendations of this evaluation when developing the GEF 6 International Waters Strategies.
- 3. The Council requested the GEF Agencies to:
  - 4) Ensure that M&E systems for environmental and socioeconomic impact are in place and consistently implemented, and that data is used and reported for management and public accountability; and

5) Ensure that M&E data and information on the impact of GEF projects be made available to the GEF Evaluation Office in a timely and transparent manner when requested.

#### Decision 23/2012 Annual Monitoring Review FY12: Part I

- 1. The Council having reviewed GEF/C.43/05/Rev.01, <u>Annual Monitoring Review FY 12:</u>

  <u>Part I</u>, welcomed the overall finding that the GEF portfolio under implementation in

  2012 performed satisfactorily across all focal areas. The Council welcomed the inclusion
  of an annual status update on Enabling Activities and Programmatic Approaches as well
  as the information provided on the National Portfolio Formulation Exercise (NPFE).
- 2. The Council requested the Secretariat to align its reporting requirements to the streamlining measures undertaken in the Project Cycle.

#### Decision 24/2012 Streamlining of Project Cycle

- 1. The Council, having reviewed document GEF/C.43/06, <u>Streamlining of Project Cycle</u>, appreciated the cooperative manner in which the GEF Secretariat and the Agencies have worked together to arrive at a set of streamlining and cost saving measures in GEF procedures and practices, and welcomed its implementation by January 2013.
- 2. The Council supported the streamlining measures described in the document. The Council also agreed to increase the MSP grant ceiling to \$2 million from the current \$1 million with delegated approval authority to the CEO with the understanding that this grant ceiling will be re-evaluated in the context of GEF-6.
- 3. The Council requested that the Secretariat, building on the existing GEF Results Based Management framework, propose relevant measures to report on the effectiveness and efficiency of the streamlining reforms for the Annual Monitoring Review. The Council encouraged the Secretariat and the Agencies to continue to collaborate on further streamlining reforms. The Secretariat is requested to report on progress achieved at the November 2013 Council meeting.
- 4. The Council thanked the Working Group for its guidance on this exercise and noted that the Group has concluded its work.

#### Decision 25/2012 Progress Report: Accreditation Process for GEF Project Agencies

1. The Council, having reviewed GEF/C.43/07, <u>Progress Report: Accreditation Process for GEF Project Agencies</u>, noted the status of the Stage II reviews by the Accreditation Panel to date and the need for further reviews of several candidate agencies, including field

- visits as appropriate, in order to verify their compliance with all minimum Fiduciary Standards and Environmental and Social Safeguards of the GEF.
- Recognizing the need to review the outcomes and experiences with the first round of reviews, the Council decided to postpone consideration of a second round of accreditation until its June 2013 meeting, pending the conclusion of all ongoing Stage II reviews by the Accreditation Panel.

#### Decision 26/2012 Financial Projections for GEF-5 Programming Options

- 1. The Council, having reviewed document GEF/C.43/08, <u>Financial Projections for GEF-5</u>
  <u>Programming Options</u>, expressed regret regarding the prospect of a shortfall in resources available for programming in GEF-5.
- 2. The Council regretted that the potential shortfall is a result of some Contributing Participants not fulfilling their financial pledges and the contribution deferrals they have brought about. The Council noted its appreciation of Contributing Participants who have delivered on their pledges. The Council urged all Contributing Participants to undertake efforts to make good on their pledges, which will allow release of deferred contributions.
- 3. The Council agreed that, as a contingency measure, the Secretariat undertakes programming maintaining the balance among the original allocations in the GEF-5 replenishment decision, assisting least developed countries (LDCs) and small island developing states (SIDS) in accessing resources, and supporting core obligations to the conventions for which the GEF is a or the financial mechanism.
- 4. The Council requested the Secretariat to report on the progress in programming and the status of any shortfall as well as proposed programming measures to manage the shortfall at the 44th meeting of the GEF Council in June 2013.

#### Decision 27/2012 Work Program

The Council, having reviewed document GEF/C.43/09, Work Program, approved the
work program comprising twenty eight (28) project concepts and one programmatic
approach, subject to comments made during the Council meeting and additional
comments that may be submitted in writing to the Secretariat by November 29, 2012.
One other project concept associated with a previously approved programmatic
approach was also approved.

1. The Council, having reviewed document GEF/C.43/CRP.01, Report of the Selection and Review Committee, agreed to:

- Take note of the GEF CEO/Chairperson and EO Director's goals and objectives for FY12 and FY13;
- ii. Notwithstanding the good performance of the EO Director, and upon his explicit request to the SRC to grant a relatively low increase, provide the EO Director with only a 2.2% merit-based salary adjustment and request the SRC Chair to communicate this decision to the World Bank Human Resources;
- iii. Request the SRC to undertake the Performance Objectives Review process for the newly appointed GEF CEO/Chairperson in the spring of 2013 as well as the EO Director, and eventually to recommend to the fall 2013 Council meeting any adjustment to the GEF CEO's salary.
