Work Program for GEF Trust Fund

- At each Council meeting the GEF Secretariat puts forward to Council a set of projects and programs that we have received from countries and have gone through a rigorous review process.
- June Work Program is still in the final stages of reviewing projects, and it is to be finalized and posted on the GEF website on May 30th.
- The Work Program is in the magnitude of around \$1B. It is expected that several of the IPs in this work program along with PIFs supporting the Focal Areas will be funded.



The critical role of policy coherence in the work of the GEF


Policy coherence can be defined as the systematic promotion of mutually reinforcing policy actions across government departments and agencies, creating synergies towards achieving the agreed objectives

GEF KM&L Strategy aims to enable & support "systematic" and coordinated approach to generate / capture / share / transfer critical knowledge

- to inform and enhance project design, portfolio management, policy development, resource mobilization, etc.
- to build capacity and foster collaboration, innovation and scale-up through demonstration and learning across the GEF Partnership.

Key Principles:

- Broad engagement
- Highly consultative
- Evidence-based, with Theory of Change
- Practical & utility oriented
- Responsive to stakeholder needs, including the GEF Partnership
- Cost-effective
- Informed by industry best practice
- Aligned with GEF-8 replenishment goals and delivery

Assessment of Agency Policies, **Practices & KM Platforms** Strategy Drafting; Consultations 4. Council Paper, Decision, Adoption and Resource Allocation 5. Partnership-wide Implementation
