Third GBFF Council Meeting December 16-20, 2024 Virtual Meeting

COUNTRY MAXIMUM DOLLAR VALUE OF FUNDING REQUEST(S)

FOR THE THIRD SELECTION ROUND WITHIN THE FIRST PROGRAMMING TRANCHE OF

THE GLOBAL BIODIVERSITY FRAMEWORK FUND

- 1. At its first meeting, the Global Biodiversity Framework Fund (GBFF) Council approved the Policy on Allocation of Resources for the GBFF, which sets out the rules governing the allocation of GBFF financial resources to projects¹.
- 2. Approval of the Policy on Allocation of Resources for the GBFF, triggered the first programming tranche of the GBFF, which opened US\$211 million for programming, corresponding to all pledges to the GBFF confirmed by the Trustee at that time, minus corporate budget needs.
- 3. As per paragraph 11 of the Policy, the Secretariat, when opening the first programming tranche, published, for all eligible countries, the maximum total dollar value of new funding request(s) they can submit during the programming tranche².
- 4. Since the opening of the first programming tranche, two selection rounds were carried out leading to the approval of 22 Project Preparation Grant (PPG) requests.
- 5. Table 1 presents, for each eligible country, information on the maximum dollar value of funding request(s) for the third selection round, given the respective country ceilings and the amounts used by projects with PPG approved in the first two selection rounds.
- 6. In the third selection round, which opened on August 8, 2024, and will close on September 30, 2024, eligible countries are invited to submit PPG request(s) with aggregated GBFF project costs (including GBFF project financing, PPG, and associated agency fees) that are no larger than that shown in the last column of Table 1 to ensure consistency with agreed country-specific ceilings.
