Theme: Private Sector Live! Engagement for Innovation and Job Growth

Description: This side event will introduce innovative ideas for expanding the private sector engagement with the GEF partnership. The event will feature a panel discussion with key private sector experts followed by a networking (or "speed-dating") session. The "speed-dating" session will give the partners a unique opportunity to discuss the partnership models, outstanding results and achievements, and potential future concepts. The Mexican private sector along with the Government representatives will conclude the event with a session featuring prominent local business players.

Proposed Layout: The structure for these two coordinated side-events is designed to highlight local private sector efforts in Mexico; followed by an innovative two part networking event in a highly interactive space promoting dialogue while exposing participants to innovative concepts, partnerships models, and outstanding projects.

- Prior to the both sessions, posters of outstanding GEF and private sector projects will be displayed in the room or on adjacent hallway.
- A special "speed-dating" networking section will help create excitement and direct engagement between country representatives, agencies, and private sector guests. High round "café" style tables will be used.

	Kick-off: Facilitator explains how the concept works
	 The Audience will then have the opportunity to visit speakers and other companies at their tables for 8 mins, view the posters up close, and obtain hand-outs, business cards, etc. After 8 minutes, a bell will sound and participants move to a different table. If we have twenty tables and 100 attendees, each table can anticipate five guests per round. This would be repeated eight times, allowing each guest to visit eight tables in the 65 min session. Each table could potentially interact directly with 40 attendees. We are anticipating having more than two dozen representatives with "posters" for their successful private sector ventures, including the Energy sector, food and water sector, the financing sector as well as GEF implementing agencies.
